Skateboarding Australia (SbA) is a subsidiary of Skate Australia (SA). For the purpose of this declaration, 'SbA' means and includes Skateboarding Australia, its members (including Clubs) and their respective directors, officers, members, servants or agents.

- RULES:
The SA Constitution:
(a) Constitutes a contract between me and SbA. I will be bound by the SA Constitution, any regulations made under the Constitution and the SA Rules and Regulations (Bylaws) and my club Constitution (if appropriate).
(b) Is made in the pursuit of a common object, namely the mutual and collective benefits, of SbA, the members of SbA (including me) and skating activities;
(c) Is necessary and reasonable for promoting the objective of SbA and particularly the advancement and protection of skateboarding activities.

WARNING: Skateboarding activities can be inherently dangerous and serious accidents can and do happen which may result in me being injured. I declare that I have voluntarily read and understand this warning and accept and assume the inherent risks in skateboarding activities.

EXCLUSION OF LIABILITY: Except to the extent that the Trade Practices Act 1974(Cth) or other legislation applies, and cannot by contract be excluded, I agree that as a term of my membership that I absolve SbA from all liability however arising from injury or damage however caused (whether fatal or otherwise) arising out of my membership and/or participation in any SbA authorized recognized activity in any way due to any negligent act, breach of duty, default and/or omission one on the part of SbA.

- RELEASE AND INDEMNITY:
In consideration of SbA accepting my application for membership, I:
1. Release and forever discharge them from all actions, suits, proceedings, claims, demands, losses, damages, penalties, costs and expenses however arising that I may have or may have had but for this release arising from or in connection with my membership and /or participation in any SbA authorized or recognized activity; and
2. Indemnify SbA to the extent permitted under, whether caused or contributed to, directly or indirectly, by any act or omission (including negligence) on the part of SbA, Trade Practices ACT 1974 (Cth) or otherwise by law in respect of any actions, suits, proceedings, claims, demands, losses, damages, costs, expenses, penalties and fines arising as a result of or in connection with my membership and/or participation in any SbA authorized or recognized activity whether caused or contributed to, directly or indirectly, by any act or omission (including negligence) on the part of SbA.
3. acknowledge and consent to photographs and electronic images being taken of me while participating in SbA events including StreetWise and SbA sanctioned events. - 1 Warrant that I am medically fit (including physically and mentally) to compete in the event and that I have not been advised otherwise by a medical practitioner.
- 2 Agree that I am participating in Event at my own risk and acknowledge that all Skateboarding Australia activities including skateboarding are risky and inherently dangerous and may result in serious personal injury including permanent disability and/or death to me as a participant in the Event and that may or will involve the risk of severe economic or property loss and damage and I understand that such injury or loss may result not only from my actions but from the actions, omissions or negligence of others.
- 3 Warrant that I will inspect the competition area and all fixtures, fittings, equipment, and other things supplied, provided or used in or related to the conduct of the Event and agree that I will not participate in the Event unless I am completely satisfied with the adequacy and conditions.
- 4 Agree to abide by the rules and regulations of the Event and Skateboarding Australia and I will abide by all written and verbal instructions as may from time to time be given by the Event Organiser and/or their appointed personnel. I agree that failure to comply with any rule may result in disqualification from the event. I agree that I will at all times participate in the event with fair play and sportsmanship.
- 5 Agree that except where provided or required by law and such cannot be excluded, it is a term of my participation in the Event (if accepted) that Skateboarding Australia and the Event Organiser are each absolved from all liability and claims however arising from injury or damage however caused (whether fatal or otherwise) arising out of my participation in the Event. I acknowledge that where I am a consumer of recreational services, as defined by any relevant law, certain terms and rights implied into a contract for the supply of goods or services may be excluded. I acknowledge that these implied terms and rights and any liability of Skateboarding Australia and / or the Event Organiser flowing from them, are expressly excluded by this registration form.
- 6 Release and forever discharge Skateboarding Australia and the Event Organiser from all and any claim, right or cause of action however arising, whether or not presently ascertained, immediate, future or contingent, which I may otherwise have for or arising out of loss of my life or injury, damage or loss of any description whatsoever and howsoever caused which I may suffer or sustain in the course of or consequent upon my participation in the Event.
- 7 Indemnify and keep indemnified Skateboarding Australia and the Event Organiser against any claim, right or cause of action howsoever arising, whether or not presently ascertained, immediate, future or contingent which I may have for or arising out of loss of my life or injury, damage or loss of any description whatsoever and howsoever caused which I may suffer or sustain in the course of or consequent upon my participation in the Event.
